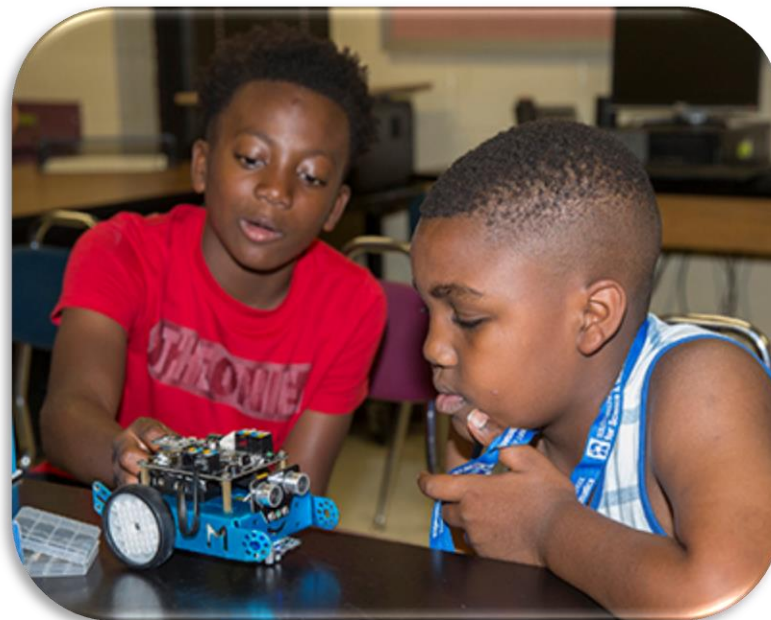

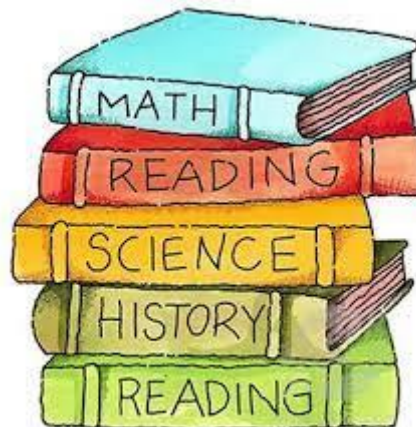
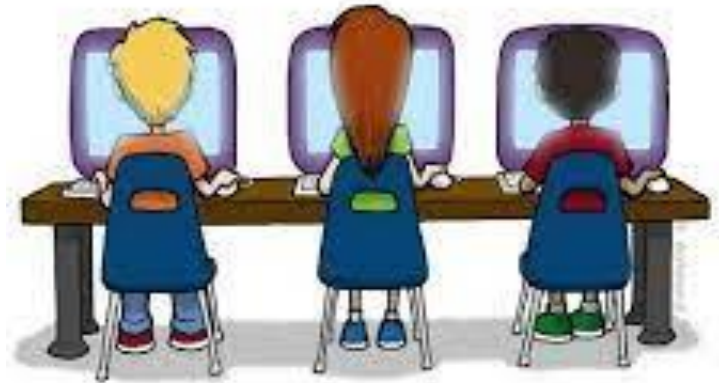

Second Reading – JICI Weapon

Objects which may be used to inflict bodily harm or death shall not be allowed on any school or district property or at any school sponsored event. These objects include, but are not limited to:

- firearms
- knives
- razors
- box cutters
- metal knuckles
- slingshots
- Tasers or stun guns
- pepper spray
- bludgeons
- blackjacks

This prohibition shall apply on school grounds, in school buildings, on buses, or at school-related functions. Vehicles parked on school property, may not contain any of the aforementioned items.

Policies



JCDAG - CELL PHONES/TECHNOLOGY AND COMMUNICATION DEVICES

– Primary/Elementary Students

- Primary or elementary students may not display or use a personal electronic device while on school property, including the school bus, or attending a school-related activity, whether on or off school property, during the school day.
- The student-owned device must be powered off during the school day.
- The district will make an exception to this rule if the student needs the device for a legitimate medical reason. The principal must have written/approved evidence of the student's medical need on file.

– Middle School Students

- Students may possess or use personal electronic devices on school property until the beginning school day bell/signal. The device will also be allowed after school denoted by the ending school day bell/signal.

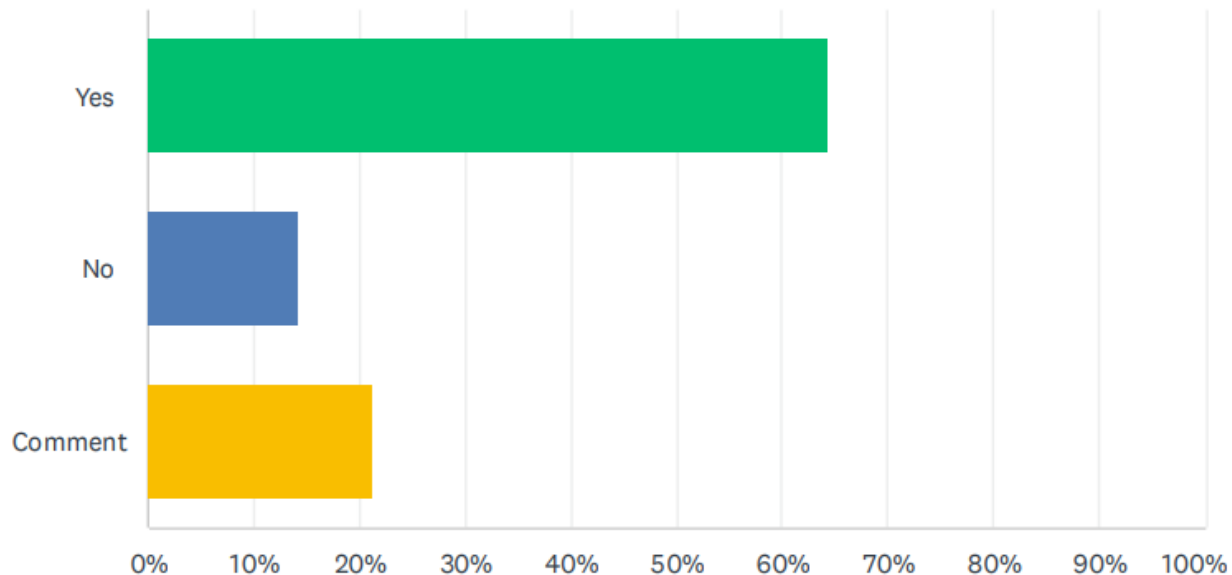
– High School Students

 - before the bell rings to begin the instructional school day

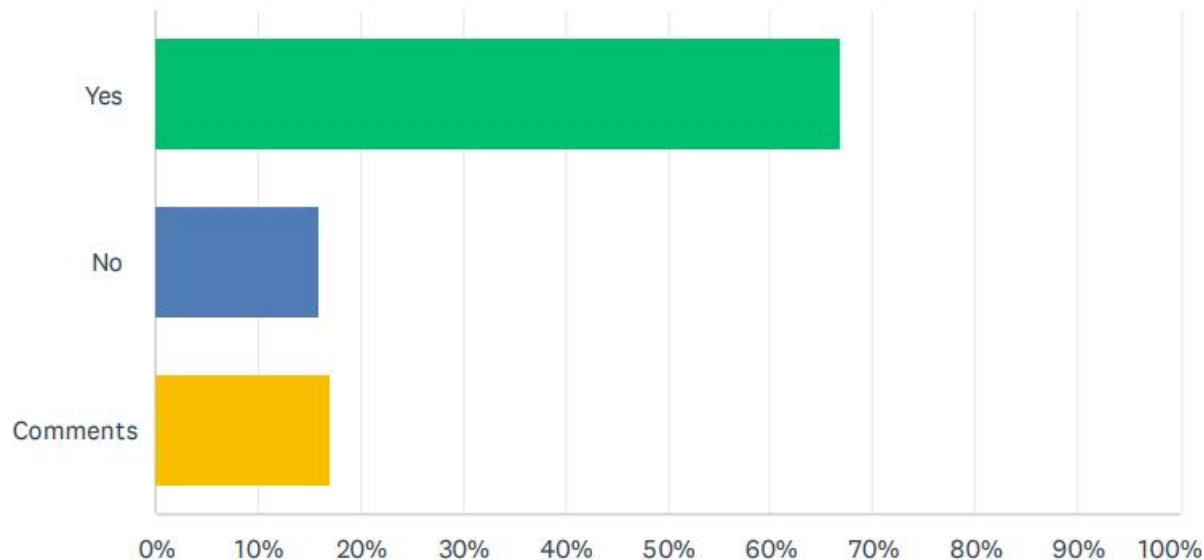

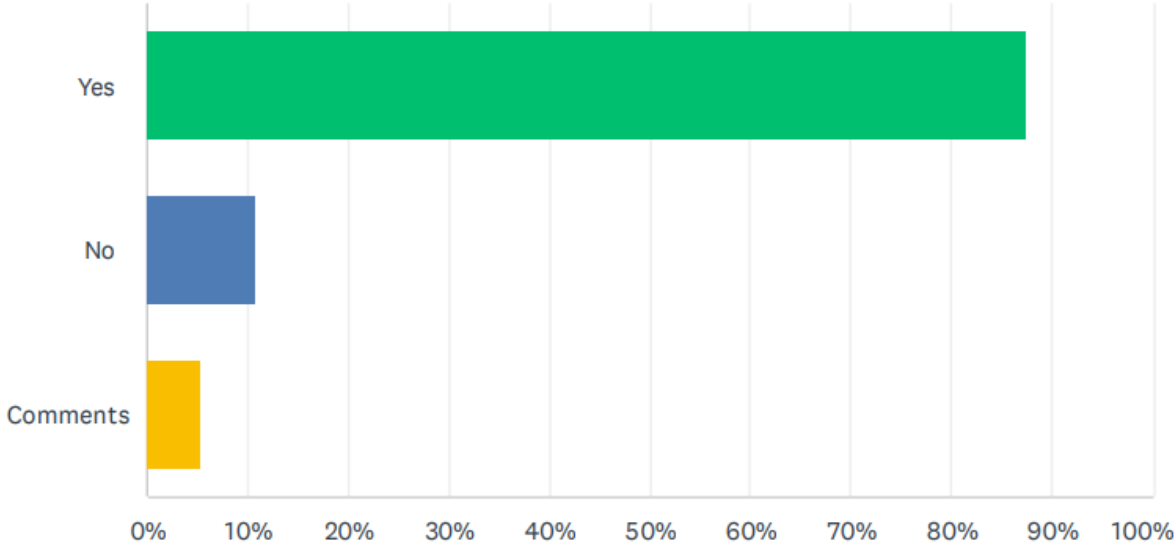

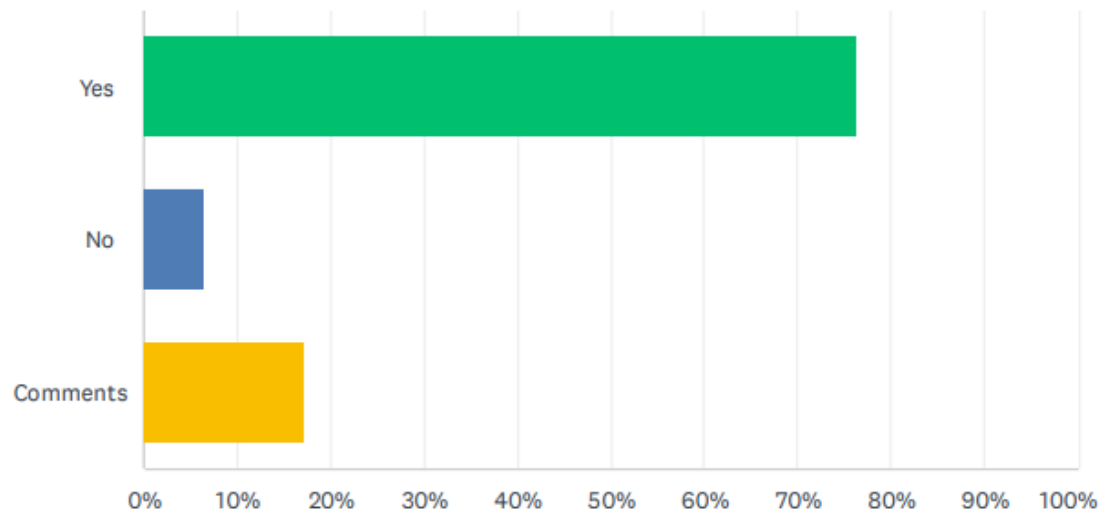

- Fourth offense and beyond – Electronic device will be confiscated for the remainder of the school year. Do you agree with these consequences?

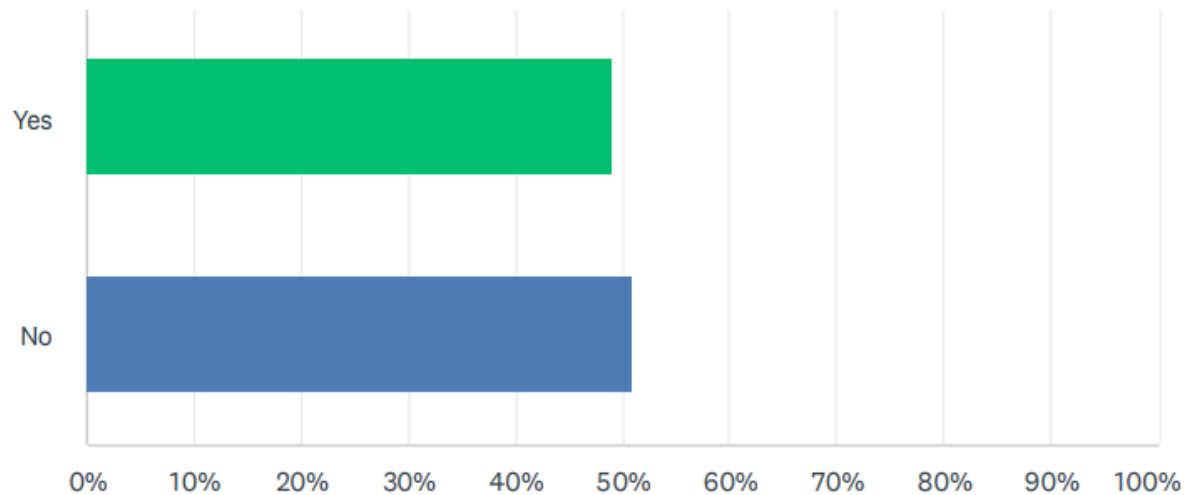

Q5 Is the current cell phone policy being enforced at your school?

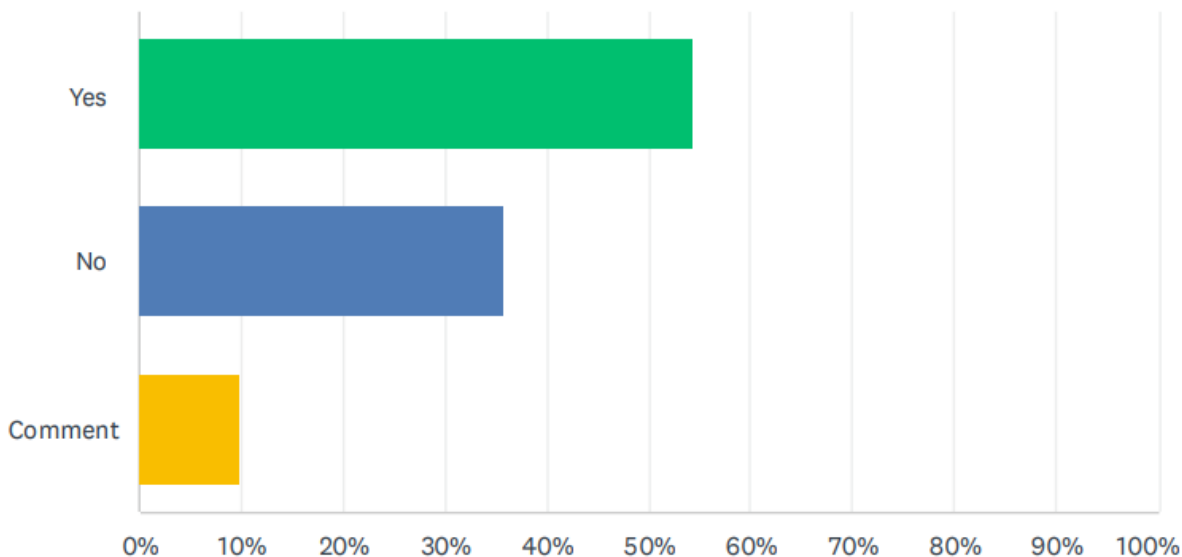

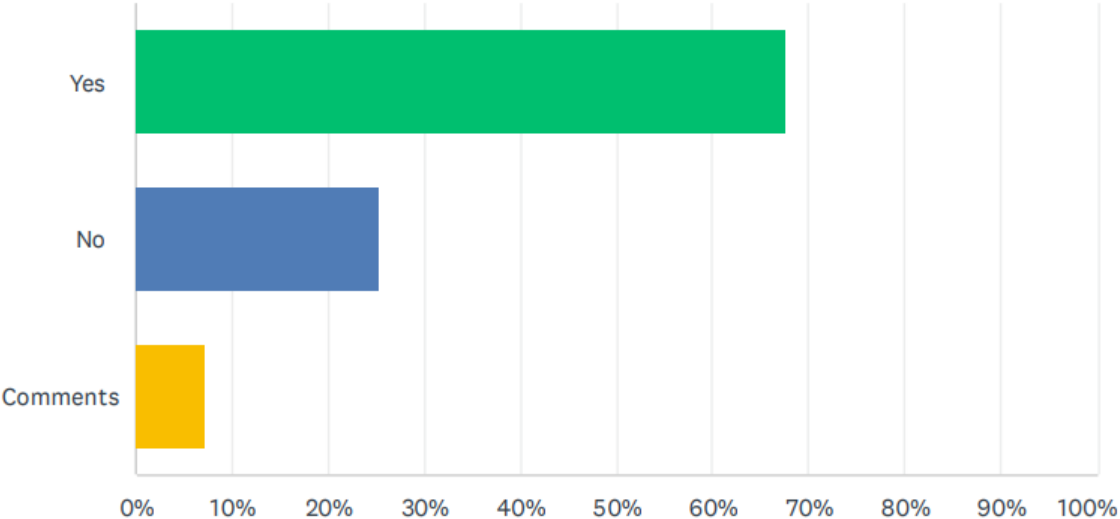

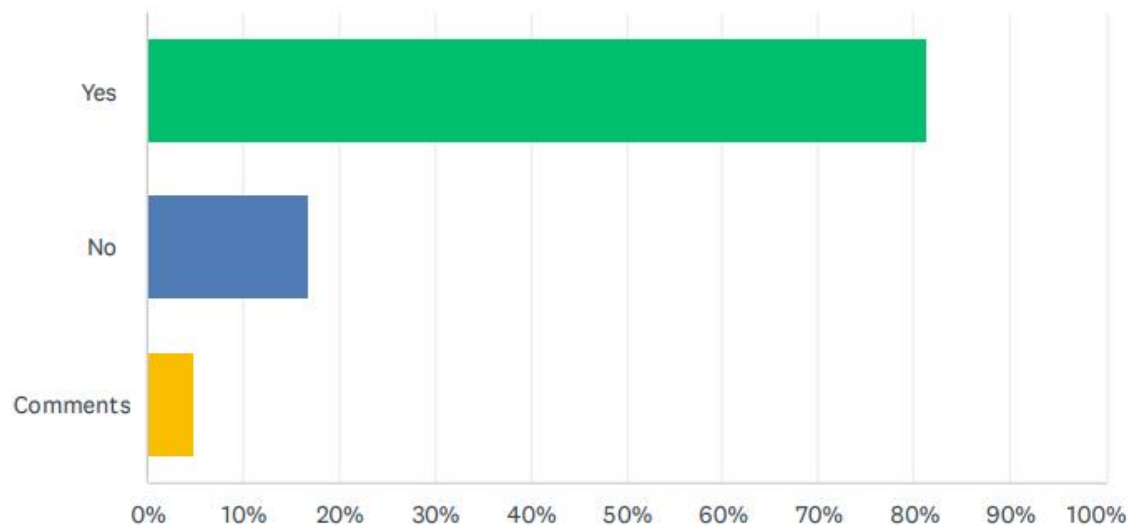

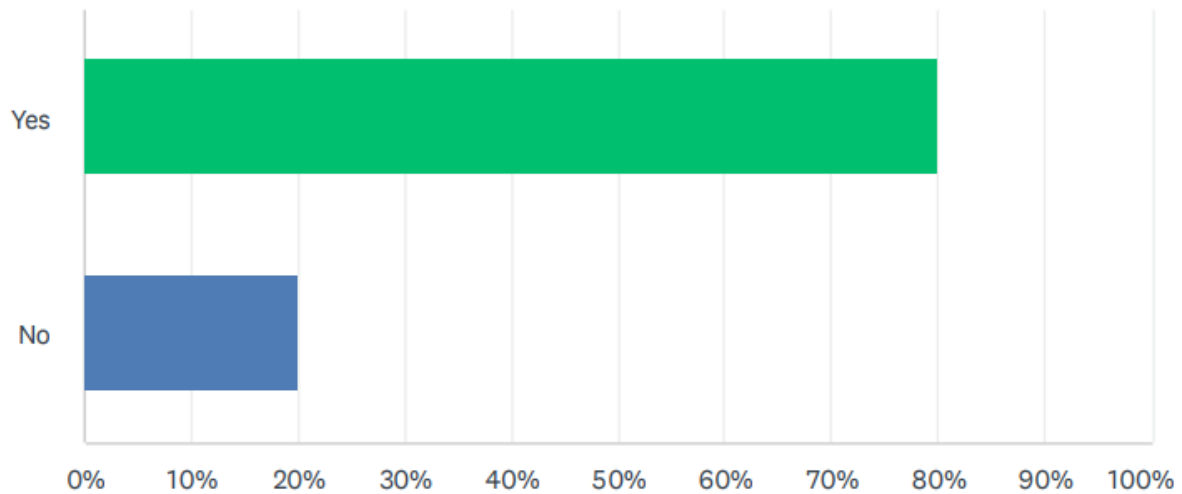
